FAMILIES FOR TEENS: A TOOLKIT FOR FOCUSING, EDUCATING AND MOTIVATING STAFF

Published first in 2006 and revised in 2008, this Toolkit is a curriculum for staff training on achieving permanence for older children in care.

To begin discussion of each topic, Lewis and Heffernan adapt an issue of Bob Lewis' popular newsletter for child welfare professionals, *What Do You Think?* They then present a case study and pose questions for more in depth consideration of the topic. The authors' goal is to move child welfare workers from understanding to "doing." Thus, in the case studies and questions, they emphasize practical action steps to achieve permanence. Each section concludes by asking participants to list their next action steps. The study of each of the 41 topics is designed to be completed within the time-frame of the one-hour staff meeting.
